Welcome – Johnna Darragh Ernst, co – chair

#### **Approval of the Minutes**

- October 27, 2014 (Attachment 1)
  - Jennifer Weidner moved to approve the minutes.
  - o Joyce Weiner seconded the motion.
  - Minutes approved.

#### Review of Infograph (Attachment 2)

- Invest in Early Care and Education
  - Move: the fourth dot point to the first dot point on the left hand side of document.
  - Add: Provides a significant number of early childhood jobs and generates considerable revenue in its own right.
  - Clarification is needed for: the statement for every 100 new jobs 56 jobs are created in other industries.
  - o Confirm the gold color on the bottom is the same color as the rest of the document.
  - This document should be shared with new elected representatives in the state legislature.
  - The document should be shared with high school and college counselors, local civic and philanthropic groups.
  - Staff will follow-up with Illinois Action for Children to verify if the data includes Head
     Start/Early Head Start dollars.
- Follow Your Passion
  - Changed: we can make more than \$10 for every dollar invested to: we can save more than \$7 for every dollar invested.
  - This document along with Children Deserve Quality Care and Education are awaiting final approval from IDHS. Once approval has been given the documents can be distributed.

#### **Next Steps of the Infographs**

Distribution

- Follow Your Passion. Target audience consists of career advisors at two- and four-year colleges and universities, and high school guidance counselors.
  - We can purchase a list of high school guidance counselors throughout the state.
  - We also need to target early childhood educators and child development faculty.
  - Timeline:
    - Materials should be sent the second week of January and then send out again at the end of January.
  - Share at the Higher Ed Forum, February ELC meeting, Illinois Voices for Children.
- Children Deserve Quality Care.
  - Target audience consists of key councils and agencies around the state.
  - Should not target the exact audience as Follow Your Passion.
  - Should be shared with specific legislators, including those that sit on the Elementary and Secondary Education Committee.
  - Legislators that have community colleges in their district should also be included in the distribution list.
- Other topics to address
  - No additional infograph topics were introduced at this time. The committee will address the need for additional topics at future WDP meetings.
  - At the February WDP meeting we will review feedback we have received in order to inform our next steps, or additional infographs that might be needed in the future.

#### **Meeting Minutes Follow-up**

- Gateways Scholarship Program Policies
  - Question: Should Gateways Scholarship contracts only be issued to schools who articulate with other schools?
    - Use the scholarship as a lever.
    - Currently Gateways policy says that practitioners need to wait a year before they can apply for a scholarship, this is often an obstacle in terms of progressing towards degrees.
    - Appropriate for the Workforce, Development and Pathways committee to make
      a friendly recommendation regarding moving the timeframe from one year to
      six months in order to apply/receive the Gateways Scholarship.
    - Question: Is there an impact on funding from ISBE?
      - ISBE was in partnership with reviewing the income limits, timeline etc. with IDHS.
        - to IDHS and then IDHS and ISBE would have a discussion and work together to move this forward with the request or to disallow the request.
      - A letter could be sent to the IDHS Illinois Child Care Advisory Board with a friendly recommendation in order to request a change in the Gateways Scholarship from one year to six months.

- All committee members are in favor to move forward with a friendly recommendation to the Child Care Advisory Board.
- Great START Wage Supplement has no requirement that those receiving the scholarship or the supplement must move up to the next level (actively pursuing the next credential or completion in some way)
  - Question: Is it possible to change the timeline relative to Great START? Many new practitioners are on a waiting list, there is no requirement that those receiving the scholarship or the supplement must move up to the next level.
  - Joni suggests that we wait until the new revised wage supplement is out. It has been in process for the last two years. The ITC and ECE credentials have been placed on the revised Great START scale and the Illinois Department of Human Services Child Care Advisory Council has been thoughtful regarding the length of time that someone might stay at a certain level without needing to take any additional course work to move up. The intended use was for retention and rewarding those who take additional course work.
  - Suggestion that Anne Wharff join us at the next meeting to answer questions about the changes in the rules.
  - The changes and impacts to Illinois due to the changes of the reauthorization of the Child Care Development Block Grant should be reviewed at the February 2015 WDP telenet.
- Career Lattice and Credential Framework
  - Enhance the career lattice to include multiple access points or stackable credentials.
  - Looking at how to support students in terms of utilizing the career lattice to be beneficial, but for the lattice to be supportive across populations that potentially an additional explanation piece would be necessary.
    - Stackable credentials work is happening with the Illinois Articulation Initiative
       Panel (IAI) and in conjunction with Gateways and other state agencies.
    - How to make the Lattice more supportive of workforce development and the idea of being user friendly. Recognizing that different points on the career lattice support different roles.
    - Career Lattice might require additional language for the idea to become clear.
      - For Level 2-4 Credentials, community colleges would need to be matched up with those Credential levels in terms of certificates.
      - Possibly add another column to the Framework?
        - Issue would be can we clearly operationalize this change. This would be a very large mapping job, and who would do it.
- Race to the Top Grant Information
  - The list of the February 2014 Early Childhood Educator (ECE) Preparation Program Innovation Grant recipients was shared with the committee.
  - o Findings from this first round of grants will be analyzed and put into a report.
  - The report is expected to be released in conjunction with the Gateways Higher Ed Forum in April.

 Original grant recipients have the potential for a second round of grants in order to do a deeper dive regarding dissemination practices.

#### **Updates/Announcements**

Joyce Weiner shared information on the Preschool Development Expansion grants. Illinois received a grant of \$20,000,000. Four programs in Illinois received Early Head Start Child Care Partnership and Early Head Start Expansion Awards. Those who received grants are City of Chicago \$14,900,000, Child Care Resource & Referral in Joliet \$1,400,000, City of Rockford \$600,000, and Proviso Leyden Council for community Action, Inc. in Maywood \$1,200,000.




